It was moved by Mr. Kubalewski and seconded by Mrs. Riter to nominate Mr. Mallory for President. Voice Vote. Motion carried.


It was moved by Mr. Mallory and seconded by Mr. Kubalewski to nominate Mrs. Martyn for Vice President. Voice vote. Motion carried.
